About the Symposium

After the success of the first IACCCA Symposium, *International Symposium on Corporate Collections and Museums – Synergies and New Perspectives on Collaboration* (Stedelijk Museum, Amsterdam, 2016), IACCCA's 2nd symposium will focus on the role and the importance of site-specific commissions and art in public spaces.

The morning session, *The Role of Art in Public Spaces*, will address the historical perspectives of Art in Public Space, attempting to define the pivotal points and transformation of perception, which have shaped art as we experience it today. Focussing on contemporary art projects, this session will encourage thought leaders to drawing lines between past and present ways of conceiving and developing art projects in public space as well as in large-scale art commissions. It will be led by guests speakers **Kasper König** (Curator, Berlin), **Cristina Iglesias** (Artist, Madrid) and Sandra Bloodworth (Director of MTA Arts & Design, Metropolitan Transportation Authority, New York).

The afternoon session, *Contemporary Visions and Practice*, will focus on case studies and current practices in order to outline possible new views and visions improving and assuring the pertinence of future art projects in public space, with guests speakers **Olaf Nicolai** (Artist, Berlin), **Dorothea Strauss** (Head of Corporate Social Responsibility "La Mobilière", Bern – IACCCA Member), **Superflex** (with Jakob Fenger, Artist, Copenhagen), **Ooze Architects** (with Sylvain Hartenberg and Eva Pfannes, Architects, Rotterdam) and **Marjetica Potrč** (Artist, Berlin).

Evening Reception & Visit of the exhibition *The World on Paper*

The day will be closed by an informal drinks reception and a visit of the exhibition *The World on Paper* at the PalaisPopulaire, in company of the curator of the exhibition, Friedhelm Hütte, Global Head of Deutsche Bank Art and Claudia Schick Tanz, Senior Curator at Deutsche Bank Art.
